

Bridal Contract



Congratulations on your engagement! We are honored that you have chosen Angela's Salon to be a part of your special day. We require a few things in order to confirm your appointment date and time.

Please be aware that this is a contract that requires a valid credit card to reserve your appointment. A **50% deposit** will be charged to "Save The Date". Half of the quoted charges will be charged to your credit card upon booking and the remainder will be charged the date services are performed. However, **any cancellations made with less than 14 days prior** to the wedding date will be charged to the credit card associated with this contract. **The entire cost of the cancelled service(s) will be placed on the credit card.**

Late arrivals- If a wedding party is more than one hour late without making contact with us, the assumption is the client is a no-show. In this case, the client forfeits all deposits and payments. If a wedding party is late for the scheduled service appointment time and notifies us of a new arrival time, stylists may or may not be able to accommodate the new arrival time. If the scope of the original contract can't be fulfilled, services may be reduced; however clients are liable for the original amount.

REMINDER:

- Be sure all members of the bridal party have clean and dry hair with gel and/or styling product in their hair upon arrival.
- Please remember all accessories (veils, flowers, etc.)
- Please wear a button down shirt on the day of the up-dos.
- Please wear flip-flops if getting a pedicure.
- Please arrive for your services with your entire party on time; please consider our guests who are scheduled after you. If a wedding party is late for the stylist, the stylist may or may not be able to accommodate the new arrival time. If the scope of the original contract cannot be fulfilled due to client's tardiness, services may be reduced. However, clients are liable for the original total fee.
